## **Scottish Journal of Geology**

Short communications, and discussions of earlier papers are invited and will be published quickly; other contributions should not normally exceed 12 published pages in length. Review papers will also be considered, but it is suggested that authors contemplating submitting these should at an early stage contact the editorial board to discuss content, suitability and date of publication. Invited reviews are also published.

### **Instructions for Contributors**

Detailed instructions for contributors are published in the *Scottish Journal of Geology* Volume 29, Part 1, pp. 107–11, 1993. Intending authors must ensure that the format of their contributions complies with these instructions, as this will enable processing of their contributions with the minimum possible delay.
