

## Notes to assist authors planning to submit items for publication in the *Scottish Journal of Geology*

**Aim:** The primary aim of the Journal is to publish papers relevant to the geology of Scotland and adjacent areas including the surrounding seas. Papers of general or specialist interest as well as short communications, letters to the editor, and discussions of earlier papers are welcome, together with reviews and thematic sets publishing the results of relevant meetings and conferences. Intending authors are invited to contact editors should they wish to discuss a project.

**Online presence:** The journal is available online as part of the Lyell Collection ([www.lyellcollection.org](http://www.lyellcollection.org)) and GeoScienceWorld ([www.geoscienceworld.org](http://www.geoscienceworld.org)).

**Submission:** All contributions must be original. Papers, including figures and references should not normally exceed 12 printed pages. All submissions to *Scottish Journal of Geology* should be made online via [www.editorialmanager.com/sjg](http://www.editorialmanager.com/sjg).

**Colour:** There is no charge for the use of colour figures online and in print. Please ensure that colour files to be printed are saved as CMYK, not RGB.

**Foldouts:** These will be accepted only after consultation with the Editor, and you will be expected to cover the additional costs.

**Supplementary publication scheme:** Detailed material such as locality lists and analytical data, will be made available as Supplementary Publications. These files are hosted on the Geological Society of London figshare portal at <http://geolsoc.figshare.com>. There is a 1 GB file size limit for supplementary material, however, our submission system allows a maximum file size of 10 MB. For any supplementary material files that are larger than 10 MB, please contact the Editorial Office ([sjg@geolsoc.org.uk](mailto:sjg@geolsoc.org.uk)).

**Offprints/pdfs** may be ordered on the form provided at proof stage. You will be given free access to 50 downloads once the issue is online; details will be sent directly to the author at the time of publication.

**Open Access publishing:** Articles can be fully Open Access (Gold Open Access) on payment of an Article Processing Charge (£1000/\$2000). More information can be found at [www.geolsoc.org.uk/open-access](http://www.geolsoc.org.uk/open-access).

If you require Open Access but cannot pay the APC, the Geological Society also supports 'Green Open Access', where you can post your final post-refereed version of the article to a website or repository 12 months after the online publication date.

Authors must not post a typeset proof or final version to any website or repository unless the article is fully Open Access.
